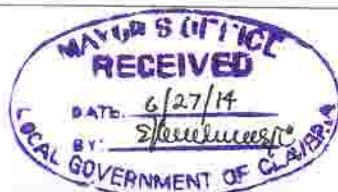

Re: Alternative Learning System-Pantawid Pamilyang Pilipino Program Municipal Summit

The Department of Education (DepEd) has always been in the highways of designing initiatives to address the Education for All (EFA) goal as part of the millennium development thrust of the country. As mandated by our constitution "the state shall ensure that every Filipino is given access to education regardless of race, color, tradition, religion and the like.
2. It is in this premise that we consider the effort of the Pantawid Pamilyang Pilipino Program (4Ps) of the national government and the Department of Education of Claveria through Alternative Learning System as an avenue to augment and improve quality of human life among the marginalized. The partnership of these government agencies therefore is a prophetic response to empower the underserved and the unreached. The Alternative learning System (ALS) of DepEd became the means of intervention to address the social adequacy issues as far as education is concerned.
3. The Summit therefore, will serve as a remarkable start for a genuine partnership of DepEd ALS and 4Ps as we launch the Continuing Basic Education for Out of school 4Ps beneficiaries (parents and children), *on July 22-23, 2014 at Claveria Covered court, Claveria, Misamis Oriental.  - a. establish strong partnership between DepEd ALS and the Local Government Unit ,DSWD through Pantawid, Pamilyang, Pillipino Program (4Ps);
